**TO RESERVE YOUR SPOT** on the tour, please submit a signed Registration Form AND Terms & Conditions, along with the \$500 USD deposit per person. Please see Cancellation Policy below.

**Holy Ground Explorations (“HGE”)** is a non-profit organization and not a travel agency. The tours put together through HGE are LAND ONLY tours. As such, HGE and any tour operator and/or its agent shall not be held liable for the faults or failures of other companies and persons used in all aspects of the tours i.e. accidents, baggage losses, strikes, political unrest or acts of God.

I will not sue or make any claims against HGE, William Daniel and/or Sharon Stolebarger, as well as nor any employees, agents or contractors for any loss, injury, sickness or damage while traveling with HGE. The terms of this release shall also be binding to any persons connected to myself, including blood relatives or administrators, and including any minors who may accompany me.

In the event the itinerary or arrangements have to be changed, this shall be done without penalty to HGE. Should changes be made due to the current conditions in the country visited, the participant shall agree to bear his/her additional expenses.

**PHYSICAL CAPABILITIES:** Trips, especially to the Middle East, can be strenuous and can, at times, involve walking long distances, uneven terrain and stairs, and long touring days. I, the participant, am physically able to participate in this tour and travel at the pace of the group as a whole. You must be able to keep up with the group with minimal assistance.

Participation in any activities while traveling with HGE is fully voluntary and by your choice. Tour Operator has the right to reject a registration without explanation or recourse .

I am legally competent to sign this release on my behalf or on behalf of any minors listed on the registration form. I agree to be responsible for any medical expenses incurred by myself or minor.

**TRAVEL INSURANCE:** *Strongly Recommended.* Travel insurance is not included in the cost of the tour. Please purchase insurance to cover the cost of your flights and monies paid to HGE should you have to cancel. Please know what your insurance company provides in case of unrest in Israel. Suggestions can be provided to you regarding companies, upon request. HGE is NOT an agent of any insurance company nor do we receive any commission or income from any insurance company. *TRAVEL INSURANCE IS HIGHLY RECOMMENDED.*

**CANCELLATION:** In order to sign up, you must complete the registration form accompanied by a \$500 per person deposit.

- Deposits are refundable if we (HGE) change the tour dates or must cancel the tour.
- Once the tour is confirmed, all payments will then be non-refundable.
- Cancellations within 30 days of travel: no refund unless tour is canceled.

**TOUR PRICE:** Prices are **per person and land only**. If not sharing a room with someone, a single supplement will be an additional cost. The tour price is based on hotel and exchange rates in effect at time of booking based on a specific number of tour members. In case of fewer participants or exchange rate changes, the price may increase. If you have requested assistance with finding a roommate, this is NOT guaranteed. We will make every attempt to procure a roommate for you, however, should one not be available, you will need to pay the single supplement shown in pricing.

**AIR RESERVATIONS:** Participants are responsible for their own airfare. Assistance will gladly be provided to you. Air information guidelines will be provided to you upon registration. Refunds from airlines are at their discretion.

**Non U.S. Citizens:** You will be responsible to contact your local Embassy or Consulate to find out what is needed to enter Israel. You are responsible to carry the correct documentation specific to your citizenship.

**BAGGAGE HANDLING:** You are allowed ONE suitcase for baggage handling purposes. You will be responsible to take your carry-on bags to/from your hotel rooms. You will need to check with your respective airlines as to what their baggage allowance is.

**PAYMENT SCHEDULE:** A \$500 per person deposit is due with your registration form and signed. See above as to cancellation policy. Final payments are due the dates shown on the Registration Form.
